1. PURPOSE

To ensure research at Morling College conforms to the *Australian Code for the Responsible Conduct of Research*, and to relate this to Morling College's values as a registered Institute of Higher Education.

3. SCOPE

This policy applies across Morling College, to research done by all researchers: staff, students, and honorary appointments. It also applies to research or research-like activities associated with coursework learning and teaching.

Note: While research undertaken by students and staff in the Faculty of Bible and Theology is also governed by the relevant and applicable policies of the Australian College of Theology, the requirements of those policies are consistent with this policy.

4. POLICY STATEMENT

Morling College (MC) commits to excellence when conducting all research, including the highest standards of researchers' conduct.

As an educational institution, MC also commits to instruct and mentor new and less experienced researchers. This includes supervision of students, both HDR and coursework projects.

5. PRINCIPLES

- 5.1 Responsibly conducted research has merit, with a justifiable goal and suitable methodology.
- 5.2 Responsible researchers show professional humility, by only undertaking research for which qualified and by being open to correction.
- 5.3 Responsible researchers are honest in all aspects of research. Where permitted, the use of generative artificial intelligence tools (including, but not limited to, ChatGPT or similar) is acknowledged.
- 5.4 Responsible researchers are accountable in all aspects of research, identifying all stakeholders before, during and after.
- 5.5 Responsible researchers show professional fairness and courtesies towards others and acknowledge their contributions.
- 5.6 Responsible researchers communicate openly and transparently. MC expects research findings to be publicly available, except where that would be unethical or impractical.
- 5.7 Responsibly conducted research shows good stewardship of resources.
- 5.8 Responsibly conducted research seeks out and meets regulatory requirements.
- 5.9 Responsible researchers respect the intrinsic worth of all people involved, be they researchers, participants, or those affected in any way.
- 5.10 Responsible researchers encourage and assist responsible practices in others and contribute to an institutional culture supporting responsible conduct.
- 5.11 All research involving human subjects shall be subject to approval and oversight by a Human Research Ethics Committee. Note: that MC will not conduct research involving animals.
- 5.12 MC treats any research misconduct seriously and all complaints will be thoroughly investigated.
- 5.13 Research can generate dilemmas in which it may be impossible to find unanimous agreement about what is right or wrong. However, responsible researchers are expected to resolve such situations, avoiding recklessness and negligence.
