1. PURPOSE

To articulate the specific admission entry requirements for Morling College awards in Education.

2. **DEFINITIONS**

The following definitions apply for the purpose of this policy:

3. SCOPE

These rules apply to courses in the Education faculty. For courses in other faculties, refer to the relevant faculty's corresponding document.

Morling College (MC) admits students to the following, according to the specific requirements of each award:

- Graduate Diploma in Education
- Master of Education
- Master of Educational Leadership

4. FORMAL REQUIREMENTS

COMMON REQUIREMENT ALL COURSES

- 4.1 Applicants whose first language is not English must provide evidence of either
 - 4.1.1 a minimum IELTS (Academic) score of 7.0 in each of the sub-skills of speaking, listening, reading, and writing, or recognised equivalent (see 4.2), attained within the last two (2) years OR
 - 4.1.2 a completed, relevant undergraduate degree in which the sole language of instruction and assessment was English.
- 4.2 MC recognises the following English language proficiency tests which can be used in place of IELTS (Academic):
 - 4.2.1 TOEFL (Test of English as a Foreign Language)
 - 4.2.2 CAE/CPE (Cambridge Certificates in Advanced English/or Proficiency)
 - 4.2.3 PTE Academic (Pearson Test of English) Admission requirements
- 4.3 To show their suitability to undertake the course, applicants need to provide two (2) references:
 - 4.3.1 Professional reference from the education sector, and
 - 4.3.2 Pastor/Minister reference

COURSE SPECIFIC REQUIREMENTS

Graduate Diploma of Education

4.4 Applicants must have completed a four-year bachelor degree with a major in education, a three-year bachelor degree and a one-year Diploma/Certificate in Education, or an equivalent combination of education and experience.

Master of Education

4.5 Applicants must have completed a four-year bachelor degree with a major in education, or a three-year bachelor degree and a Diploma/Certificate in Education, or an equivalent combination of education and experience.

Master of Educational Leadership

- 4.6 Applicants must have completed a three-year bachelor degree, in any discipline.
- 4.7 Applicants must provide evidence of their having an appropriate strategic role in an educational/training organisation.

5. EXPECTATIONS OF APPLICANTS

5.1 Applicants are expected to possess a basic level of Information and communication technology competency. As the absolute minimum, this includes the ability to use Word, Excel and PowerPoint, the ability to send and receive e-

- mail communications, and the ability to use a web-browser to access our on-line learning system (Moodle).
- 5.2 Applicants who do not have these skills will be expected to obtain them prior to commencement. Students will be taught how to access and participate in on-line tutorials, be encouraged to present work using multimedia format, and access a range of on-line resources.
