

Emeritus Status

The following standard has been prepared in order to hold senior supervisors with esteem and to recognise their potential contribution to the NSWCCPE Inc. although no longer conducting CPE Foundational units.

A CPE Educator or CPE Educational Consultant who has decided to no longer present for further accreditation reviews, and desires to continue to be involved in the life of NSWCCPE by making available their services on a limited basis, may choose to apply to the NSWCCPE Council or Executive Committee for Emeritus status within NSWCCPE.

If you have been accredited as a CPE Educator, you may apply for status as an Emeritus CPE Educator after 15 years from the time you were granted status as a Provisional CPE Educator.

If you have been accredited as a CPE Educational Consultant, you may apply for status as an Emeritus CPE Educational Consultant after 7 years from the time you were granted status as Provisional Educational Consultant.

Upon conferral of your status as an **Emeritus CPE Educator** you are granted the following privileges, and will work within the boundaries and responsibilities below:

1. be a current member of NSWCCPE and ANZACPE, and be in supervision regarding CPE supervisory activity and maintain ongoing professional development;
2. can participate in all NSWCCPE and ANZACPE supervisory workshops, study days, conferences and the like;
3. can accept requests or invitations for the supervision of individuals or groups involved in CPE, these to be contracted for a specific time and purpose;
4. only with prior NSWCCPE approval are you able to be a CPE Centre Director or conduct your own CPE programs/Units.
5. required to submit a written report to the College Council by the end of each calendar year

Upon conferral of your status as an **Emeritus CPE Educational Consultant** you are granted the following privileges, and will work within the boundaries and responsibilities below:

1. be a current member of NSWCCPE and ANZACPE, and be in supervision regarding CPE supervisory activity and maintain ongoing professional development;
2. can participate in all NSWCCPE and ANZACPE supervisory workshops, study days, conferences and the like;
3. can accept requests or invitations for the supervision of individuals or groups involved in CPE, these to be contracted for a specific time and purpose;
4. can conduct individual and group education-in-supervision as requested or invited, these to be contracted for a specific time and purpose
5. only with prior NSWCCPE approval are permitted to be a CPE Centre Director or to conduct your own CPE programs/Units.

6. required to submit a written report to the ARPS Committee by the end of February each calendar year.

The Report

The NSWCCPE Inc. is accountable for all supervisory activity and as part of our risk management process requires a written report that will include a statement on;

1. All workshops study days and conferences attended,
2. All contracts made to supervise and/or provide education-in-supervision for individuals or groups, together with the purpose and timeframe of each contract.
3. Any CPE committee activity in which you are a consultant.
4. Details of any other CPE activity in which you are involved.
